

**COAST RIDGE FOREST COUNCIL
PROPERTY OWNER RELEASE OF LIABILITY & INDEMNIFICATION**

WHEREAS, the Coast Ridge Forest Council (“CRFC”) provides fuel reduction services, including vegetation removal, piling, burning, chipping etc., at no cost to residents as a public service; and

WHEREAS, property owners may voluntarily consent to fuel reduction services on their properties; and
WHEREAS, fuel reduction services involve risks, including but not limited to the risk of property damage, aesthetic changes to vegetation, and personal injury. Therefore, the CRFC enters the following agreement with: ,

On _____ (date), whereby Property Owner releases the CRFC of liability and agrees to indemnify the CRFC for claims arising from or related to fuel reduction and/or removal activities as described herein.

1. **PROPERTY.** Property Owner warrants and guarantees they own the property identified below, hereinafter referred to as “Property.”

2. **PROJECT.** The Project is the CRFC Shaded Fuel Break Project, Phase I. Project involves construction of a shaded fuel break through the removal of vegetation, such as weeds, wood, brush, debris, and trees (Project). The Project will involve biological and cultural surveys. Project may involve the use of equipment and machinery, such as saws, pruners, hatchets, axes, tracked equipment/masticators, chippers, and other vegetation management equipment. The Project is coordinated by CRFC with work conducted by private contractors and other authorized individuals. Vehicles, equipment, and workers may enter the Property.

3. **RELEASE & WAIVER OF LIABILITY.** In consideration of the opportunity to participate in the Project, Property Owner, for themselves and their heirs, successors, legal representatives, and assigns, hereby releases, waives, and discharges the CRFC, their respective directors, officers, and agents, from liability from any and all claims arising from or related to the Project, including liability caused by the negligence of CRFC. Property Owner expressly waives their right to assert unknown claims under Civil Code § 1542.

4. **ASSUMPTION OF RISK.** The Project has certain inherent risks that cannot be eliminated regardless of the care taken to avoid injury. Specific risks vary, but risks may include damage to the Property, damage to other property on the Property, personal injury, damage to adjacent properties, and aesthetic changes to the landscape. Property Owner desires CRFC to conduct the Project and therefore accepts and assumes these risks.

5. **INDEMNIFICATION & HOLD HARMLESS.** Property Owner agrees to indemnify and hold the CRFC and its officers, employees, and agents harmless from all claims, suits, or actions of every kind arising out of or related to the Project.

6. **INSURANCE.** Property Owner acknowledges that neither Property Owner nor the Property will be covered by or eligible for any insurance coverage provided by the CRFC, including, but not limited to medical, property, pollution, and liability insurance.

7. CONSENT TO USE OF MEDIA. Property Owner agrees to allow the CRFC to use photos or video of Project activities on the Property.

8. GOVERNING LAW AND JURISDICTION. This Agreement shall be governed by the laws of the State of California, and disputes arising out of or in connection with this Agreement shall be under the exclusive jurisdiction of the Courts of the State of California.

9. PROJECT TERMINATION. Property Owner may withdraw their request for or consent to the Project at any time before the Project commences by providing written notice to Judy Rosales (jrosales@mcn.org). CRFC may cancel or terminate the Project at any time by notifying Property Owner verbally or in writing.
